### PUNKY POWER CUSTOM KICKS CONTEST GIVEAWAY RULES

THE PUNKY BREWSTER SNEAKER GIVEAWAY (THE "GIVEAWAY") WILL BE CONDUCTED IN CANADA ONLY (EXCLUDING QUÉBEC) AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. # 1. ELIGIBILITY.

- 3.2 Limit of one (1) entry per person, per day, during the Giveaway Period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries, become the sole property of Corus and will not be returned for any reason. Entries

must be received no later than the end of the Giveaway Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. - 4.3 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
